### **FIELD COORDINATOR REPORT:**

Sergio was able to secure field permits at Ethel I. Baker and C.B. Wire Schools. Manuel announced that everyone is invited to attend Southgate's Field Allocation Meeting on May 13 at Florin Community History Center 7245 Fletcher Farm Drive and would like to acquire at least 1 Elk Grove field 1 day per week. Poncy suggested that Juan's team (U-19) from Galt might want to use an Elk Grove field closer to them. Poncy stated that he was still looking into other fields to use for the Spring League and David suggested Edward Hams field as a possible site since they have a lighted facility. Poncy is still looking into the prices for a field paint machine (approximately \$650.00) and portable field poles and will present those costs at the next board meeting.

### **UNIFORM COORDINATOR REPORT:**

Jeanette stated that the Score uniform samples we looked at during the last meeting will not be able to provide uniforms that will have matching gray shirts/shorts. Score suggests choosing an alternative uniform (France Model) that will have black shorts. Challenger Sports is another uniform company that she is looking into. Sergio reminded everyone that a couple of months ago the board had agreed on a uniform from Challenger (Aztec Style). Jeanette will follow up with Challenger about that uniform and will present her findings at the next board meeting. Manuel also reminded everyone that if we want to change our colors we need to have SYSL approve it by April.
